



WHO IS IT FOR?

A **person not insured within the public health insurance system** of the Czech Republic or other EU member state can be vaccinated in this manner:

- CITIZEN OF THE CZECH REPUBLIC
- FOREIGNER (from the EU or third countries) who has long term residence in the Czech Republic for more than 90 days pursuant to the Act on the Residence of Foreign Nationals, and who meets one of the following conditions:
 - a) has a valid long-term or permanent residency permit in the Czech Republic,
 - b) holds a valid long-term visa,
 - c) is an EU citizen with confirmation of temporary residency or a permanent residency permit in the Czech Republic,
 - d) is a family member of an EU citizen with confirmation of temporary residency or a permanent residency permit in the Czech Republic.

WHERE TO GET VACCINATED?

In a designated vaccination center (at least 1 in every region). The list of designated vaccination centers is available at registrace.mzcr.cz/samoplatci/ocm.

HOW TO REGISTER?

You can register for self-paid covid-19 vaccination at crs.mzcr.cz.

WHICH VACCINE IS USED?

COMIRNATY vaccine (manufactured by BionTech/Pfizer).

HOW MUCH DOES IT COST?

The maximum price per one dose including application will not exceed CZK 810.

WHEN AND HOW DO I GET EU COVID-19 CERTIFICATE?

You can collect the certificate immediately after vaccination at the Vaccination Portal <https://ocko.uzis.cz>.

WHAT SHOULD I BRING?

- A document to verify your identity.
- A document to verify your residency permit in the Czech Republic (does not apply to Czech citizens).
- Payment card/cash (some vaccination centers accept only payment cards on the spot).

1 SELF-PAYER REGISTRATION

- Select the following option



- After entering your telephone number, you will receive **PIN1**, which you will then enter into the registration system (registration.mzcr.cz/samoplatci).
- A registration form will open for you.
- Fill in your personal details.
- Choose a vaccination center (only selected vaccination sites allow for self-payers to be vaccinated).
- **Submit your request.**
- An email confirming your registration will be sent to the email you provided.
- An SMS confirming your registration and your identification number will be sent to the telephone number you provided.
- As soon as the vaccination center of your choice lists available dates for vaccination, an invitation SMS with an **identification number (ID number) and PIN2** will be sent to the telephone number you provided. You will need both of these details to book your vaccination appointments.

2 APPOINTMENT BOOKING

- Select the following option



- Using the received **identification number (ID number) and PIN2**, you will book an appointment at your chosen vaccination center (rezervace.mzcr.cz).
- You choose the date and time of the first vaccination appointment at the vaccination center you selected during registration. The date for the second vaccination appointment will be automatically generated for you at the same vaccination center within the interval complying to the currently valid interval rules. **You have 48 hours to book your vaccination appointments.**
- If for any reason you do not book your appointments within 48 hours, you are returned to the registration and need to wait for a new invitation SMS from the vaccination center.
- You can be returned to registration maximum of 3 times, after which your registration expires.
